## SOUTH WAKE LANDFILL PUBLIC TOUR PARTICIPANT AGREEMENT AND RELEASE FORM (WAKE COUNTY VEHICLE)

THIS PARTICIPANT **AGREEMENT AND RELEASE** sets forth the terms and conditions applicable to your voluntary participation in the South Wake Landfill Public Tour:

- Participant shall wear suitable clothing including, long pants, and hard-soled closed-toe footwear.
- No participants under age 8 shall be allowed.
- Participants age 8-16 shall be accompanied and supervised by an adult at all times during the tour.
- Participants must tour the facility in a Wake County owned/leased/rented multi-passenger vehicle.
- No personal vehicles are permitted beyond South Wake Landfill gates.
- Participant must be accompanied by a Wake County Environmental Services representative during the tour.
- Participant must follow the instructions given by the Wake County Environmental Services representative at all times, and may not disembark the vehicle without permission during the tour.
- Participant must stay with the tour group.
- Participant SHALL NOT touch any equipment, materials, or waste of any kind during the tour.
- Participant may take photographs if desired.
- Wake County may photograph participant while on the tour and use any images at no charge for the <u>www.wakegov.com</u> website and/or promotional and educational materials related to Wake County public services.

If you understand and agree to these conditions, please sign and date the Participation Agreement and Release on this form. Bring a completed tour release form with you to the tour. A release form must be signed and collected for each individual tour participant prior to entering the facility gates. Thank you for your cooperation.
